



CONSULATE OF SAINT CHRISTOPHER (ST. KITTS) AND NEVIS

SHIPMENT OF CREMATED HUMAN REMAINS/FULL BODY TO ST. KITTS AND NEVIS

The Government of St. Kitts and Nevis requires compliance of the following regulations for the shipment of human Remains into the Federation of St. Kitts and Nevis. All certified copies of the requested documents must be scan and email to the Consulate of Sr. Kitts and Nevis in Toronto at least fourteen (**14**) days prior to the expected date of departure.

CREMATION

- 1. One (1) certified copy of the Death Certificate.
- 2. One (1) certified copy of Passport Identification Pages with relevant information about the deceased.
- 3. One (1) copy of Cremation Certificate.
- 4. Signed letter of contents in URN (*from the funeral home*).
- 5. Flight itinerary (date of travel, airline, flight number and exact time of arrival) of the person accompanying the remains.
- 6. Any other document as may be required.

FULL BODY

- 1. One (1) certified copy of the Death Certificate.
- 2. One (1) certified copy of the Stateent of Death.
- 3. One (1) Burial/Transit permit.
- 4. One (1) Embalmer's affidavit.
- 5. One (1) Letter of non-contagious disease from local health authority.
- 6. **One (1) Funeral Home Letter stating:**
 - That only remains are inside the casket
 - The flight itinerary (date of travel, airline, flight number and exact time of arrival) of the person accompanying the remains
 - A consignee's name, address and telephone number
 - That the body has been placed in a hermetically sealed container
 - That the hermetically sealed container has been placed in all wood outer shipping container
- 7. Proof of citizenship (e.g., a copy of Passport pages with relevant information about the deceased or Birth Certificate).

Upon receipt and review of the documents the Ministry of Health will issue a letter giving permission for the shipment of Urn or Full Body into St. Kitts and Nevis.

The person accompanying the remains must present the original copies of the requested documents upon arrival in St. Kitts and Nevis. All contents must be declared upon arrival at Customs.
